

Overwatch League Pick 'Em Promotion Official Rules ("Official Rules").
NO PURCHASE NECESSARY TO ENTER OR WIN.
PURCHASING WILL NOT INCREASE YOUR CHANCES OF WINNING.
VOID WHERE PROHIBITED OR RESTRICTED BY LAW.

Sponsor: The Overwatch League Pick 'Em Promotion (the "Promotion") is sponsored by The Overwatch League, LLC, One Blizzard Way, Irvine, CA 92618, USA (the "Sponsor").

Description: The Promotion is devised as a non-gambling promotion and is intended solely for entertainment purposes. The Promotion is based on the results of 2022 Overwatch League Matches (as defined below) and is comprised of four (4) individual Entry Periods (as defined below) which align with the following games (hereafter, individually referred to as a "Game" and collectively as "Games"): Kickoff Clash Game, Midseason Madness Game, Summer Showdown Game, and Countdown Cup/Playoffs Game. The 2022 regular season of the Overwatch League shall consist of two-hundred and forty (240) matches and the 2022 Overwatch League Playoffs Tournament (the "Playoffs Tournament") shall consist of sixty-nine (69) matches (each such match, a "Match"). Entrants (as defined below) will be awarded points by correctly predicting the teams that will win each Match as well as the loser score of each Match. The Promotion Includes a fifth Game, titled "Crystal Ball Picks", where Entrants can pick up to four (4) teams to advance to the Playoffs Tournament. For each Game, prizes will be awarded to the top Entrants who have accumulated the most points during the applicable Game, as further described in the "Prizes" Section of these Official Rules. Each Entrant may submit one (1) entry in each Game. If an Entrant enters more than one entry for a Game, the Entrant will be disqualified from such Game and no prize will be awarded to such Entrant (if applicable).

Eligibility: Promotion is only open to legal residents of the fifty (50) United States, the District of Columbia, Canada (excluding Quebec), United Kingdom, France, Germany and Spain (together, the "Eligible Jurisdictions") who are at least eighteen (18) years of age or older (or at least the age of majority in their jurisdiction of residence, whichever is older) as of date of entry (each, an "Entrant"). Employees, agents, officers and directors of the Sponsor (including Overwatch League players and teams), teamDigital Promotions, Inc. ("Administrator"), and each of their respective parents, affiliates, subsidiaries, wholesalers, retailers, distributors, suppliers, advertising and promotion agencies (hereafter collectively, "Released Parties"), other agencies, firms or companies associated with the Promotion (including any suppliers) and each such individual's immediate family members, including both natural and non-natural relations in the opinion of the Sponsor, (i.e., mother, father, sister, brother, child, husband, wife and their respective spouses (including de facto spouses), regardless of where they reside) and those living in their same households, whether or not related, are not eligible to participate or win. Void outside of the Eligible Jurisdictions and where prohibited by law. All applicable federal, state, local & provincial laws apply. By submitting an entry, participating and ticking the relevant box(es), Entrants agree be bound by to these Official Rules and the decisions of the Sponsor, which are final and binding in all matters related to this Promotion.

To be eligible to participate in this Promotion, you must have an account in good standing with Blizzard Entertainment, Inc., ("Blizzard") in compliance with all applicable terms and conditions. If you already have a Blizzard Battle.net account, you must login to link to the Game Play page using your Blizzard Battle.net account user name and password to participate in the applicable Game. If you do not have

an Blizzard Battle.net account, you must register before participating in any Game. Blizzard's Battle.net accounts are free of charge and can be obtained at <https://us.account.battle.net/creation/flow/creation-full>. To register, complete and submit the Blizzard account registration form according to the instructions provided.

Promotion Period: The Promotion is scheduled to start no later than 11:00:00 AM Pacific Time ("PT") on April 29, 2022 (the "Start Time") and is scheduled to end at the end of the Playoffs Tournament currently scheduled to take place on November 5, 2022 ("Promotion Period"). There will be four (4) individual entry periods as follows (each, an "Entry Period"): Entry Period #1: Kickoff Clash Game which is currently scheduled to take place from 4/29/22-6/5/22, Entry Period #2: Midseason Madness Game which is currently scheduled to take place from 6/6/22-7/24/22, Entry Period #3: Summer Showdown Game which is currently scheduled to take place from 8/1/22-9/11/22, and Entry Period #4: Countdown Cup/Playoffs Game which is currently scheduled to take place from 9/12/22-11/6/22. The Crystal Ball Picks Game is currently scheduled to open as of the Start Time and is currently scheduled to end on November 5, 2022 at 11:59 PM PT. Each Entry Period begins at 10:00:00 AM PT and ends at the conclusion of the final Match of that Game. Entrants shall be solely responsible for ascertaining the relevant times in their applicable time zones. All dates are subject to change. See "To Participate" Section below for additional details.

To Participate:

(1) To register to participate, during the Promotion Period visit <https://pickem.overwatchleague.com> ("Website") and click on the banners, buttons and/or links to access the applicable Game registration page. As part of the registration process, you may be asked if you wish to receive promotional emails from Sponsor. Consenting to receive promotional emails is optional and is not required for sign up or participation in this Promotion, and will not impact your chances of winning. Upon completion of the registration process, you may link to the Game Play page using your newly designated user name and password to participate in the applicable Game. Entrants are responsible for ensuring that all contact information is up-to-date and accurate. **Limit one (1) Game User Registration form submission per person and per email address per Game for the duration of the Promotion Period. Additional registration forms received from any such person or email address for any Game after the first registration form received from that person or email address for such Game will be void.** The use of script, macro or any other device to automate or subvert the registration process is prohibited and all such registrations will be void. Registration form submissions will be accepted throughout the Promotion Period, in accordance with the terms of these Official Rules.

(2) Each Game match-up will be posted to the Website after all participating teams have been confirmed. Your goal is to select the teams that you think will win each Match through the Game, as well as the final scores for the losing team of each Match.

(3) Click on the "Save" button prior to the expiration of the Entry Period for each Match to submit your Match predictions. Predictions for each Match can be submitted/modified in accordance with the posted deadlines. Entrant's last predictions that are received prior to the expiration of the Entry Period will be used to tabulate his/her score. No points will be granted for Matches in respect of which a Match result is not submitted prior to the expiration of the Entry Period.

Scoring: For each Entry Period, Entrants will earn points based on the prediction of the winning team and the final scores for the losing team. For each correct winner prediction, the Entrant will receive two

(2) points (for a maximum of one-hundred and sixty (160) points through the duration of each Entry Period). For each correct loser score prediction, the Entrant will receive one (1) point (for a maximum of eighty (80) points through the duration of the Entry Period). If, at any time during a Game, any Match has a double points border (visible on the Entrant's prediction page), any Entrant who makes a correct prediction will receive double the points they would otherwise normally receive. During the Entry Period #2, two (2) additional Matches will be held. During Entry Period #4, nine (9) additional Matches will be held.

During the Crystal Ball Picks event, Entrants will receive two (2) points for correctly predicting up to four (4) teams that will advance to the Playoffs Tournament and ten (10) points for correctly picking the winner of the Playoffs Tournament (for a maximum of sixteen (16) additional points).

Leaderboard Scores will be reset between each Entry Period.

Sponsor and/or Administrator may choose to implement a streak bonus for any Game, pursuant to which Entrants will be eligible to receive points for consecutively predicting the correct winning team a certain number of times in a row (a "Streak"). Points for Streaks shall be granted to Entrants in accordance with the below:

1. Streak of three (3) consecutive Matches - one (1) point
2. Streak of five (5) consecutive Matches - two additional (2) points
3. Streak of ten (10) consecutive Matches - five additional (5) points. Additionally, all points earned in the tenth Match of Entrant's Streak will be doubled.
4. Streak of twenty (20) consecutive Matches - ten additional (10) points. Additionally, all points earned in the twentieth Match of Entrant's Streak will be tripled.
5. Streak of twenty (25) consecutive Matches - ten additional (10) points. Additionally, all points earned in the twenty-fifth Match of Entrant's Streak will be tripled.

Selecting an incorrect winning team will end a Streak. Skipping the selection of a Match (not predicted) is not counted as an incorrect prediction, and will not end a Streak.

Tie-Breaker (if applicable): In the event of a tie for any Game and/or prize, the designated prize will be awarded to the tied Entrant who locked in their prediction for the final Match of the applicable Game first based on time and date stamp as determined by the Sponsors and subject to their compliance with these Official Rules. If a tie still exists after the above tie-breakers have been completed, each applicable tied Entrant will be asked to answer via phone (voice call) and/or video conferencing, without assistance of any kind, an Overwatch League-themed question selected by Sponsor with a time limit of five (5) seconds. The Entrant that answers the question correctly in the shortest amount of time will be declared the winner for that applicable Game and/or prize. In the event multiple tied Entrants answer the question correctly in the same amount of time, another question will be asked and this process will be repeated until only one of the Entrants answers the posed question correctly in the shortest amount of time. Once a question has been answered incorrectly, the Entrant will not be able to answer again on that question. If all tied Entrants answer the question incorrectly, another question will be asked, and the above process will be repeated until only one of the Entrants answers the question posed correctly.

in the shortest amount of time. A question that is not answered in the permitted time period will be considered answered incorrectly.

Winner Selection/Notification: The highest scoring Entrant for each Game will receive the Grand Prize, the second highest scoring Entrant will receive the First Prize, and the eight (8) Entrants who receive the 3rd-10th highest scores will receive a Second Prize. All potential winners will be determined in accordance with the process above by the Sponsor's judges in Irvine, CA. The potential prize winner(s) will be notified by email approximately 10 business days from the completion of the applicable Entry Period. Entrants are solely responsible for checking their email inboxes to see if they are a potential winner. Where allowed by applicable law, potential winner(s) will be required to execute and return a Declaration of Eligibility, Liability Release and (where legal) Publicity Release and any other documents required by Sponsors within two (2) days of date of receipt of documents (each such document being no more than a re-statement of one or more provisions of these Official Rules). If any prize or prize notification is returned as undeliverable, Administrator is unable to contact a potential winner or if a potential winner is not in compliance with these Official Rules, such potential winner will be disqualified and, time permitting may re-award the applicable prize to an alternate winner according to point score.

The tabulation of points and identification of potential winners will be conducted by judges whose decisions along with Sponsors' are final and binding with respect to these Official Rules and in all other matters relating to this Game. Prizes will be awarded to the person named on the applicable Game registration form regardless of whether that is the authorized account holder of the email address from which said registration form was submitted (subject to verification of eligibility and compliance with the terms of these Official Rules).

In the event that any Match is canceled, suspended (and not resumed) or preempted (and not resumed) for any reason during any Game, the prizes will be awarded based on points accumulated for those Matches that occurred as scheduled.

Prizes: Four (4) Grand Prizes (One (1) Prize per Entry Period): One (1) Overwatch Lootbox Premium Gift box and \$500USD in the form of a check. Approximate Retail Value ("ARV"): \$690USD each. **Four (4) First Prizes (One (1) Prize per Entry Period):** One (1) Overwatch Lootbox Premium Gift box and \$100USD in the form of a check. ARV: \$290USD each. **Thirty-two (32) Second Prizes (Eight (8) Prizes per Entry Period):** \$50USD in the form of a check. ARV: \$50USD each. For applicable territories, and other than as required by law, costs and expenses associated with the acceptance and receipt of a prize including, without limitation, all federal, state, local & provincial taxes are each winner's sole responsibility. Total ARV of all prizes: \$5,520USD. Winners shall receive applicable prizes within thirty (30) days following notification and confirmation in accordance with the procedures set out above. Entrant's shall be obliged to supply relevant details to Sponsor and/or Administrator to claim a prize. No prize shall be paid to anyone other than the Entrant.

Declaration of Personal Information Consent: Entrant hereby grants the right, if they win, to the Released Parties to use their name, photograph, statements, and address (city & state/province/territory), worldwide and on the Released Parties' websites and social media (Facebook, Twitter, Instagram, Tik Tok) and content-sharing platforms (YouTube, Dailymotion, etc.) accounts, for a duration of two (2) years as from the ending of the Promotion Period, without further compensation, in

connection with each Game and for advertising and publicity purposes. Prize winners agree to Released Parties' use of their names and photograph, for advertising and publicity purposes, in the conditions described above, without additional compensation, unless prohibited by law.

Miscellaneous: By agreeing to the Official Rules, each Entrant accepts and agrees to accept and be bound by these Official Rules and by the decisions of the Sponsor, made in accordance with the Official Rules, which shall be final and binding in all respects. No transfer, assignment, or substitution of a prize (or portion thereof) is permitted.

The Released Parties and their parents, affiliated and subsidiary companies and advertising and promotion agencies are not responsible for lost, incomplete, inaccurate, garbled, late, delayed, undelivered or misdirected entries, registrations, predictions, submissions, downloads, installations, registrations, usernames, Game points, team/number of Match selections or revisions which do not result from the Released Parties breach of these Official Rules or legal obligations; theft, destruction or unauthorized access to, or alteration of, entries, registrations, predictions, submissions, team/number of game which do not result from the Released Parties breach of these Official Rules or legal obligations; failures or malfunctions of phones/mobile devices (including wireless phones/handsets or other wireless devices), phone lines or telephone systems; interrupted or unavailable network, server, cable, satellite, Internet Service Provider (ISP) or other connections as long as they do not result from the Released Parties breach of these Official Rules or legal obligations; any error, omission, interruption, defect or delay in any transmission or communication; traffic congestion on the Internet or for any technical problem, including, but not limited to, any damage to Entrant's or any other person's computer or mobile device related to or resulting from participation in this Promotion which does not result from the Released Parties breach of these Official Rules or legal obligations; errors or ambiguity in these Official Rules, in any Game-related advertisements or other materials; the selection or announcement of potential winners or the distribution of prizes; the cancellation, suspension or preemption of any Match, scoring tabulation or timing errors or other problems or errors of any kind whether mechanical, human, electronic, typographical, printing or otherwise (the following language is not applicable to residents of the United Kingdom and France: including without limitation, errors which may occur in connection with the administration of the Sweepstakes, the processing of entries, the announcement of a prize, for any injury or damage to Entrant's or any other person's computer or other device relating to or resulting from participation in this Game, or for printing, typographical, human or other errors appearing in these Official Rules or other Game-related materials). Entrants are responsible for any charges of online service providers or wireless carriers. Sponsor reserves the right to void any entries of entrants and disqualify such Entrants whom Sponsor believes have attempted to tamper with or impair the administration, security, fairness or proper play of this Promotion and/or is in violation of these Official Rules.

By entering, each Entrant agrees that the Released Parties and their parents, affiliated and subsidiary companies and advertising and promotion agencies shall have no liability and will be held harmless by Entrant for any claim, action, liability, loss, injury or damage (1) to Entrant or any other person or entity, including, without limitation, personal injury or death to Entrant or any other person or damage to personal or real property, due in whole or in part, directly or indirectly, by reason of the acceptance, possession, use or misuse of any prize and any travel or travel-related activity thereto or participation in this Promotion, and (2) any and all taxes and other fees applicable to the prizes received by the prize

winners. The Released Parties reserve the right to halt or modify the Promotion at any time during the Promotion Period exclusively if force majeure events compromise any Game's fairness or integrity. **Caution: any attempt by an Entrant to deliberately damage any web site or undermine the legitimate operation of the Promotion is a violation of criminal and civil laws and should such an attempt be made, Released Parties reserve the right to seek any and all remedies available from any such Entrant to the fullest extent permitted by law.**

In the event that any Game is challenged by any legal or regulatory authority, Released Parties reserve the right to discontinue or modify the individual Game, or to disqualify Entrants residing in the affected geographic areas. In such event, the Sponsors shall have no liability to any Entrants who are disqualified due to such an action. In the event of any ambiguity(s) or error(s) in these Official Rules, the Released Parties reserve the right to modify these Official Rules for clarification purposes or to correct any such ambiguity or error(s) without materially affecting the Official Rules of the Promotion.

Limitation of Liability and Disclaimer of Warranties (not applicable to German residents): Unless they have breached their obligations under these Official Rules or legal obligations, other than under your applicable statutory rights and except as required by local laws, in no event will the Released Parties and/or their parents, affiliates, subsidiaries and related companies, their advertising or promotion agencies or their respective officers, directors, employees, representatives and agents, be responsible or liable for any damages or losses of any kind, including, but not limited to, direct, indirect, incidental (not applicable in France), consequential (not applicable in France) or punitive damages (not applicable in France) arising out of Entrant's ability to access to and use of the service and/or the individual Game, downloading from and/or printing material downloaded from the service and any website associated with this Promotion. - (v) Any potential liability on the part of Sponsor or Released Parties for any warranties and for claims based on the German Product Liability Act shall not be affected.

Binding Arbitration (only applicable in the US): Except where prohibited by applicable law, the parties, including all Entrants, waive all rights to trial in any action or proceeding instituted in connection with these Official Rules, the overall Promotion or any Promotion shall be settled by binding arbitration in accordance with the commercial arbitration rules of the American Arbitration Association. Any such controversy or claim shall be arbitrated on an individual basis and shall not be consolidated in any arbitration with any claim or controversy of any other party. The arbitration shall be conducted in the State of California, in the City of Irvine, County of Orange.

For German Residents Only: Any recourse to the courts of law is excluded.

Jurisdiction: French Entrants submit to the jurisdiction of the competent courts in France and all legal proceedings arising out of or relating to the Promotion.

Governing Law and Jurisdiction (Does not apply to residents of Germany): To the fullest extent permitted by applicable law, these Official Rules and the interpretation of its terms shall be governed by and construed in accordance with the laws of the State of California (for U.S. residents) or France (for residents of France) without regard to its conflicts of laws rules. For any matters which are not subject to arbitration as set forth in these Official Rules and/or in connection with the entering of any judgment on an arbitration award in connection with these Official Rules and/or the Promotion, the parties irrevocably submit and consent to the exclusive jurisdiction and venue of the California state and federal courts located in the City of Irvine, County of Orange, and State of California, USA (for U.S. residents

only). The parties agree not to raise the defense of forum non conveniens. In the case of Entrants which are resident in the United Kingdom, the provisions of this clause as set out above shall not apply.

Privacy: By participating in this Promotion, Entrants hereby acknowledge that Sponsor may collect and use their personal information in compliance with applicable laws and regulations and its Privacy Policy accessible at <https://overwatchleague.com/en-us/legal/privacy-policy> in order to organize, run and monitor the Promotion as well as for carrying out publicity activities on it. Entrants confirm that they have acknowledged the The Overwatch League Privacy Policy. Entrants' personal information may be transferred to the United States of America for the purpose of this Promotion, in accordance with The Overwatch League Privacy Policy. Entrants have the right to access, ask for erasure, and correction of their personal information and can request such action as detailed in The Overwatch League Privacy Policy.
