

## Overwatch League Playoff Bracket Challenge Official Rules.

NO PURCHASE NECESSARY TO ENTER OR WIN.

PURCHASING WILL NOT INCREASE YOUR CHANCES OF WINNING.

VOID WHERE PROHIBITED OR RESTRICTED BY LAW.

**Sponsors:** The Overwatch League Playoff Bracket Challenge (the "Game") is sponsored by the Overwatch League, LLC, One Blizzard Way, Irvine, CA 92618-3616 ("OWL" or "Sponsor").

**Description:** The Game is devised as a non-gambling promotion and is intended solely for entertainment purposes. The Game is based on the results of the 2020 Playoffs – Bracket Builder (the "2020 Playoffs"). The Playoffs consist of eighteen (18) North America Matches, eight (8) Asia Matches, and six (6) Grand Finals Weekend Matches for a total of thirty-two (32) matches. For North America the rounds are as follows: a) Round 1 consisting of two (2) standard match-ups; b) Round 2 consisting of three (3) standard match-ups; c) Round 3 consisting of four (4) standard match-ups and two (2) Losers Bracket match-ups; d) Round 4 consisting of two (2) standard match-ups and two (2) Losers Bracket match-ups; e) Round 5 consisting of one (1) standard match-up and one (1) Losers Bracket match-up; and f) Round 6 consisting of one (1) North America finals match-up. For Asia, the rounds are as follows: a) Round 1 consisting of one (1) standard match-up; b) Round 2 consisting of two (2) standard match-ups; c) Round 3 consisting of two (2) standard match-ups and one (1) Losers Bracket match-up; d) Round 4 consisting of one (1) standard match-up and one (1) Losers Bracket match-up; e) Round 5 consisting of one (1) Asia Finals match-up. Once the North America and Asia brackets are complete, participants will be prompted to complete the Grand Finals round which consists of: a) Round 1 consisting of two (2) standard match-ups and one (1) Losers Bracket match-up; b) Round 2 consisting of one (1) standard match-up and one (1) Losers Bracket match-up; and c) Grand Finals consisting of one (1) match-up. "Entrants" (as defined below) will be awarded points by correctly predicting the teams that will win each Match in the 2020 Playoffs as well as predicting team opponent selections for select matches and specific Match score for Grand Finals. The Highest Score Prize will be awarded to the Entrant who has accumulated the most points during the Game. In the event an Entrant submits a "Perfect Bracket" whereby he/she accurately predicts the outcome of all Matches and the final scores for the losing team of each applicable Match, he/she may be eligible to win the Perfect Score Prize. Each Entrant may submit one (1) entry/bracket throughout the Game. If an Entrant exceeds the entry limitations; the Entrant will be disqualified and no prizes will be awarded to such Entrant (if applicable).

**Eligibility:** Game is only open to legal residents of the fifty (50) United States, the District of Columbia, United Kingdom, France, Germany who are at least eighteen (18) years of age or older (or at least the age of majority in their jurisdiction of residence, whichever is older) as of date of entry (each, an "Entrant"). Employees, agents, officers and directors of the Sponsor (including OWL players and teams), teamDigital Promotions, Inc. ("teamDigital" and/or "Administrator"), and each of their respective parents, affiliates, subsidiaries, wholesalers, retailers, distributors, suppliers, advertising and promotion agencies (hereafter collectively, "Released Parties"), other agencies, firms or companies associated with the promotion (including any suppliers) and each such individual's immediate family members including both natural and non-natural relations in the opinion of the Sponsor, (i.e., mother,

father, sister, brother, child, husband, wife and their respective spouses (including de facto spouses), regardless of where they reside) and those living in their same households, whether or not related, are not eligible to participate or win. Void outside of the fifty (50) United States, the District of Columbia, United Kingdom, France, Germany, and where prohibited by law. All applicable federal, state and local laws apply. By submitting an entry, participating and ticking the relevant box(es), entrants agree be bound by to these Official Rules and the decisions of the Sponsor, which are final and binding in all matters related to this Game.

To be eligible to participate in this Promotion, you must have an account in good standing with Activision Publishing, Inc., in compliance with all applicable terms and conditions. Activision accounts are free of charge and can be obtained at <https://profile.callofduty.com/cdl/register-email>.

**Game Period:** The Game is scheduled to start no later than 6:00:00PM Pacific Time ("PT") on August 28, 2020 and is scheduled to end at 12:00:00PM PT on September 3, 2020 ("Game Period"). Entrants shall be solely responsible for ascertaining the relevant times in their applicable time zones.

All dates are subject to change. See "To Participate" section below for additional details.

**To Participate:** (1) To register to participate, during the Game Period visit <https://brackets.overwatchleague.com/playoffs> ("website") and click on the banners, buttons and/or links to access the Game registration page. If you already have a Battle.net account, you must login to link to the Game Play page using your Battle.net account user name and password to participate in the Game. If you do not have a Battle.net account, you must register before participating in this Game. Battle.net accounts are free and can be obtained at <https://brackets.overwatchleague.com/playoffs>. To register, complete and submit the Battle.net account registration form according to the instructions provided. As part of the registration process, you may be asked if you wish to receive promotional emails from Sponsor. Consenting to receive promotional emails is optional and is not required for sign up or participation in this Game, and will not impact your chances of winning. Upon completion of the registration process, you may link to the Game Play page using your newly designated user name and password to participate in the Game. Entrants are responsible for ensuring that all contact information is up-to-date and accurate. **Limit one (1) Game User Registration form submission per person and per email address for the duration of the Game Period. Additional registration forms received from any such person or email address after the first registration form received from that person or email address will be void.** The use of script, macro or any other device to automate or subvert the registration process is prohibited and all such registrations will be void. Registration form submissions will be accepted throughout the Game Period, in accordance with the terms of these Official Rules.

(2) Each Game match-up will be posted to the website after all participating teams have been confirmed. Your goal is to select the teams that you think will win each Match through and including the Grand Finals Match, as well as the final scores for the winning and losing team of each Match.

(3) Click on the "Save" button prior to the expiration of the Game Period for each Match to submit your Bracket Predictions. Bracket predictions for each Match can be submitted/modified in accordance with the posted deadlines. Entrant's last predictions that are received prior to the expiration of the Game Period will be used to tabulate his/her bracket score. No points will be granted for Matches in respect of which a Bracket is not submitted prior to the expiration of the Game Period.

Released Parties are not responsible for lost, incomplete, inaccurate, garbled, late, delayed, undelivered or misdirected entries, registrations, predictions or submissions; theft, destruction or unauthorized access to, or alteration of, entries, registrations, predictions or submissions which do not result from the Released Parties breach of these Official Rules or legal obligations; failures or malfunctions of your phones, phone lines or telephone systems; interrupted or unavailable network, server, cable, satellite, Internet Service Provider (ISP), or other connections; any error, omission, interruption, defect or delay in any of your transmission or communication; traffic congestion on the Internet or for any technical problem, including but not limited to any damage to Entrant's or any other person's computer related to or resulting from participation in this Game; the tabulating of points, the cancellation, suspension or preemption of any Match, injuries or other unavailability of players, scoring tabulations or timing errors or other problems or errors of any kind whether mechanical, human, electronic, typographical, printing or otherwise which do not result from the Released Parties breach of these Official Rules or legal obligations. Entrants are responsible for any charges of online service providers or wireless carriers. Sponsor reserves the right to void any entries of entrants and disqualify such Entrants whom Sponsor believes have attempted to tamper with or impair the administration, security, fairness or proper play of this Game and/or is in violation of these Official Rules.

**Scoring:** Entrants will earn points based on the correct prediction of winning teams in each Match, as well as and the final scores for the losing team of each Match. The number of points awarded for each correct pick will increase with each round of the Playoff Games. Game points will be awarded as follows:

A Perfect Bracket score is 190 points. In order to have a Perfect Bracket, you must accurately predict the outcome of all Matches and the final scores for the losing team of all Matches prior to expiration of the Game Period. A maximum of one (1) Perfect Bracket prize may be awarded. **If no entrant entered a Perfect Bracket during the Game Period, then no Perfect Score prize will be awarded in the Game.** At the conclusion of the Game, Entrant scores will be calculated and prize(s) will be awarded to the top scoring Entrants as described below.

**Tie-Breaker for Perfect Score Prize (if applicable):** In the event multiple eligible Entrants submit a Perfect Score, the Perfect Score Prize will be divided equally between each Entrant in question.

**Tie-Breaker for Highest Score Prize (if applicable):** In the event of a tie for the Highest Score Prize, the designated prize will be awarded to the tied Entrant who correctly selected the team that won the Grand Finals. If two or more Entrants correctly selected the team that won the Grand Finals, the designated prize will be awarded to the tied Entrants who locked in their prediction for the final Match first based on time and date stamp as determined by the Sponsors and subject to their compliance with these Official Rules. If a tie still exists after the above tie-breakers have been completed, each applicable tied Entrant will be asked to answer via phone, without assistance of any kind, an OWL themed question selected by Sponsor with a time limit of five (5) seconds. The one (1) Entrant that answers the question correctly in the shortest amount of time, will be declared the Highest Score Prize winner. In the event multiple tied Entrants answer the question correctly in the same amount of time, another question will be asked and this process will be repeated until only one

of the Entrants answers the posed question correctly in the shortest amount of time. Once a question has been answered incorrectly, the Entrant will not be able to answer again on that question. If all tied Entrants answer the question incorrectly, another question will be asked, and the above process will be repeated until only one of the Entrants answers the question posed correctly in the shortest amount of time. A question that is not answered in the permitted time period will be considered answered incorrectly.

**Winner Selection/Notification:** The Perfect Score Prize will only be awarded in the event that an Entrant submits a Perfect Bracket, pending eligibility verification. In addition, the Entrant with the highest (in the event no Entrant has submitted a Perfect Bracket) or next highest point score (in the event a Perfect Bracket was submitted) at the end of the Game (or tie-breaker, if applicable) will be declared the Highest Score Prize winner. The next ten (10) highest scoring winners will be named Runners Up Prize winners and will receive a Runners Up Prize.

Potential winners will be determined in accordance with the process above by the Sponsor's judges in Irvine, CA. The potential prize winner(s) will be notified on or about September 12, 2020 by email. Entrants are solely responsible for checking their email inboxes to see if they are a potential winner. Where allowed by applicable law, potential winner(s) winner will be required to execute and return a Declaration of Eligibility, Liability Release and (where legal) Publicity Release and any other documents required by Sponsors within two (2) days of date of receipt of documents. If any prize or prize notification is returned as undeliverable, Administrator is unable to contact a potential winner or if a potential winner is not in compliance with these Official Rules, such potential winner will be disqualified and, time permitting may re-award the applicable prize to an alternate winner according to point score.

The tabulation of points and identification of potential winners will be conducted by judges whose decisions along with Sponsors' are final and binding with respect to these Official Rules and in all other matters relating to this Game. Prizes will be awarded to the person named on the applicable Game registration form regardless of whether that is the authorized account holder of the email address from which said registration form was submitted (subject to verification of eligibility and compliance with the terms of these Official Rules).

In the event that any Match related to this Game is canceled, suspended (and not resumed) or preempted (and not resumed) for any reason during the Game Period, the Perfect Score Prize will be forfeited, and the Highest Score Prize will be awarded based on points accumulated for those Matches that occurred up until that point.

**Prizes: One (1) Perfect Score Prize Only:** The Perfect Score Prize will only be awarded in the event that an Entrant submits a Perfect Bracket prior to 12:00:00PM PT on September 3, 2020. In order to have a Perfect Bracket, you must accurately predict the outcome of all Matches and the final scores for the losing team of each Match in accordance to these Official Rules. **If no Entrant submits a Perfect Bracket, the Perfect Score Prize will not be awarded.** The Perfect Score Prize is a one (1) lump sum payment of one-hundred thousand U.S. dollars (\$100,000 USD/€84,772 EUR) (the "**Perfect Score Prize**"). For the avoidance of doubt, if multiple eligible Entrants submit a Perfect Entry (as described above) in respect of the same Prediction Period, the Jackpot Prize will be divided equally between each Entrant in question (for example, if there are 3 Entrants with a perfect entry, each Entrant will

receive \$33,333.33 USD/28,257.33 EUR). **One (1) Highest Score Prize:** Winner will receive a one (1) lump sum payment of ten thousand U.S. dollars (\$10,000 USD/€8,477.20 EUR). For applicable territories, and other than as required by law, costs and expenses associated with the acceptance and receipt of a prize including, without limitation, all federal, state and local taxes are each winner's sole responsibility. Maximum total ARV of all prizes: \$110,000.00 USD/€93,249.20 EUR. Winners shall receive applicable prizes within [30] days following notification and confirmation in accordance with the procedures set out above and all prizes shall be remitted via cheque [or bank transfer]. Entrant's shall be obliged to supply relevant details to Sponsor and/or Administrator to claim the Prize. No Prize shall be paid to anyone other than the Entrant. **Ten (10) Runners Up Prizes:** Each Runner Up Prize winner will receive one (1) OWL Prize pack. ARV: \$250.00 USD each. **Limitation of Liability and Disclaimer of Warranties (not applicable to German residents):** Other than under your applicable statutory rights and except as required by local laws, in no event will the released parties and/or their parents, affiliates, subsidiaries and related companies, their advertising or promotion agencies or their respective officers, directors, employees, representatives and agents, be responsible or liable for any damages or losses of any kind, including, but not limited to, direct, indirect, incidental, consequential (not applicable in France) or punitive damages arising out of Entrant's ability to access to and use of the service and/or the Game, downloading from and/or printing material downloaded from the service and any website associated with this Game. The parties agree not to raise the defense of forum non conveniens.

**Privacy:** By participating in this Challenge, Participant hereby acknowledge that OWL may collect and use their personal information in compliance with applicable laws and regulations and its Privacy Policy accessible at <https://callofdutyleague.com/en-us/privacy> in order to organize, run and monitor the Challenge as well as for carrying out publicity activities on it. Participants confirm that they have acknowledged OWL's Privacy Policy. Participants' personal information may be transferred to the United States of America for the purpose of this Challenge, in adequation with OWL's Privacy Policy. Entrants have the right to access, ask for erasure, and correction of their personal information and can request such action as detailed in OWL's Privacy Policy..
